Academic Achievement:

Juniors completed the ACT on March 9th; three students will be doing Make-up ACT with Mr. Livingston. Make-up day is supposed to be March 23rd, but due to Spring Break a date in April will be re-scheduled. Middle school FORWARD schedule is being developed for April 19-29. All students, including virtual students, must take assessments in person. Planning includes testing for virtual students on Fridays or other times when the hybrid learners are not in the building.

Supportive Climate:

A few more students have returned to middle school hybrid from the virtual learning. Families are impressed with school's safety protocols and six foot distancing expectations. Group A is currently maxed with student limit in order to continue following safety protocols put into place.

Our team just started exploring and training for Building Culturally Responsive Systems. A book study for middle school staff is in the works to help understand inequities and how to nurture/support students with self identity & growth.

Effective Communication:

Senior Class advisors have been sharing information about planning for Senior Class Trip. Calendar committee has created three calendars; and, voting has taken place in regard to selected calendar.

Use of Data & Resources:

Discussed with local investigator how Gaggle filtering system monitors student use/data online. Two possible threats had come up, but had been stopped due to Gaggle. Summer school discussions have begun for middle school students needing more support, especially if two or more content areas were failing during first semester. Retention is not the first option, especially due to the pandemic and virtual learning. I'll attach a template to my report. Depending on student need and family response we will plan for a possible two-week summer school August session to help with learning gaps.

Attendance:

Students are adjusting well to two day per week schedule. Friday's check-in for ACP is still a work in progress.
