Attendance, Truancy, and Family Connections Collaboration Team

The committee has had multiple meetings to coordinate services to find solutions to help with truancy-related issues. Individuals from the Bayfield School, the Red Cliff family Services programs, Red Cliff Planning Department, and the Red Cliff Community Health Center are participants on the committee. The topics have been Tribal Court truancy updates, the vacancy for next year with the Home School Coordinator position, the Red Cliffs Clinics involvement with families, how to best engage them with the school and clinic, and a discussion regarding a School-Based Mental Health Grant.

Team Time with Teachers, Students and Parents, Guardians, and Foster Parents

We have had two successful meeting opportunities with parents, teachers, staff, and students individually, talking about the student's performance and the staff's ability to share their perspectives. It's a time for everyone, including parents, to discuss their child's current academic and behavioral progress and find ways to improve the sharing. Everyone has a stake in the meeting, including the student who provides their own insight into their classroom experience. The goal is to end with an action plan for the student and teachers related to classroom expectations from the staff, parents, and student. We look forward to more meetings to follow. This gives our staff the ability to reach out and help a student(s) who may need a change regarding academics or behaviors that are
