## **Pupil Services**

The Pupil Services/School Counselors met April 26 (Doug Jardine, Karla Vinci, Dan Livingston, Stephanie Lewis, (Muskadee Montano proctoring state tests)); May 3 (Doug, Stephanie, Muskadee); May 10 (Stephanie, Karla, Dan)

- School Based Mental Health Professionals Project
  - Update Application completed and given to Randi to finish the budget. Application is due May 13, 2022. Additional data included in the, with application 101 students (25%) in the Bayfield District have an IEP, twelve referrals currently being processed. 2020-2021 State Forward testing resulted in 79% of students demonstrating scores of "Basic" or "Below Basic".

- This data suggests a need for a full time psychologist, social worker, and an additional school counselor to address the current unmet mental health and behavioral needs of our students including addressing absenteeism.

- Training the teacher 3-day virtual training. Can add a 1-day blended training with no additional cost. \$3300 + 125 manuals. Course would be taught in 6 45- minute sessions, not consecutive. Training sessions are offered June, July, August, and September.

- Share out of curriculum meeting (Karla, Janine, Melinda, Steph, Muskadee) 5/9/22: Melinda looking for different/additional curriculum for School Connect and is exploring 7 Mindsets.
  - Janine suggested that **Choice Theory** needs to be revisited throughout the District as it focuses on foundational relationships student-teacher, teacher teacher, teacher-family, etc.
  - In the past, Bayfield and Washburn districts both embraced this top-down directive from administration.
- ACP The day (MS/HS) is being adjusted to absorb the troller time next year. Xello is one small tool to be used (possibly culminating in EfE?) Dean of Instruction needs to align ACP standards within existing classes English, elective/pathway courses. Need to bring speakers in ALL classes include recent graduates. HS students stay connected to recent grads.
- An elementary teacher suggested a need for mindfulness in every classroom teach teachers to teach coping skills and mindfulness.
- Review of specific student needs and 5<sup>th</sup> Grade Transition schedule.

The **Wellness Committee** met May 10, 2022. Present: Stephanie Lewis, Karla Vinci, Melinda Suelflow, and Dan Livingston

- Discussed the b.e.s.t. Universal Screener need to purchase for next year and have it on the calendar much like academic screeners. Discussed areas that should be the focus of next year's action plan. Suggestions include updating staff support needs:
  - Staff Wellness Choice Theory, IC tool rights behavior write up, para access to disc referrals and in-progress monitoring,
    - needs to come from the top down. Staff wants follow up to student concerns.
      - Friday half days use for staff morale and team building
      - Need to follow through with EE some staff not doing
  - Need a common annual calendar

**Pupil Services Team** – continues to meet weekly to address student academic and behavioral concerns. Twenty-two students are currently being monitored for supports and needs. **Human Resources** 

- There are currently seven applicants for the special education paraprofessional openings.

### **Special Education**

- Special education case managers met May 4, 2022, to discuss next year's caseloads.
  - Per DPI caseload analysis, two elementary and one middle school case manager are beyond the recommended student limit.

- 1:1 paraprofessional needs continue to increase to address lagging student academics and behaviors. Two paras are needed to replace retirees and three additional paraprofessionals are needed to support students, as needs are indicated in their IFPs.
- Initial referrals also continue to increase.
- 103 IEP/evaluation meetings have been held this year. Nineteen new referrals have been received, seven are complete, the other twelve are either in progress or we are waiting for the parent/guardian consent to test.
