April 9, 2024

- Mike, students of concern Amy S. is doing a check in/out 3x/day with two 2nd graders. Amy D. is doing small groups with the entire class every Monday.
- CCEIS money is available for at-risk students (students identified on PST for support.) Interventions, staff training. For example, a summer book study pay for the books, stipend for reading it, PD in the fall.

School Counselor Team Meetings Strategic Priority - Student & Staff Health and Wellbeing, Student Success

Amy Day, Karla Vinci, Stephanie Lewis met on March 22 and April 5, 2024 and discussed the following topics:

- Steph submitted the Civil Rights Data Collection (CRDC) on April 1. We need to look into a "law enforcement" indicator or check box on behavior referrals.
- Second Step has curriculum for high school thoughts? Who and when would this be taught?
- Scholarships only one senior student currently planning to attend a 4-year school. Only one student has applied for scholarships. This class is small, most students looking at a technical college. Karla has sent information to families and students multiple times.
- Junior conferences are ongoing, scheduled during students' IEs.
- b.e.s.t. Universal Behavior Screening window set for April 15-29.
- Spring plan PST review b.e.s.t. and MAP results. Develop a student profile for students needing intervention and a plan to be in place in the fall.
- Roles and responsibilities process for the pupil services team.
- Middle school PST/student concern meetings need to be in person.
- MAP testing in IEs. This setting is not ideal/working. It is recommended that MAP testing
 go back to testing in the content area classroom. Classroom teachers don't want to miss
 classroom instruction use data to set goals WITH students. Staff can use the results of
 the MAP assessments to guide instruction.
- Service Learning Steph met with Holly. Holly is going to develop a survey for staff to see what service learning is already in place and how we can help to expand this at each grade level.
- Concern that student concern conversation is a duplication of pupil services team discussions.
- Karla Vinci, MS/HS Counselor reports:
- Junior Conferences are in full swing. Hope to wrap them up by the end of April.
- April 30 The annual outing for juniors is called "Yellowjacket for a Day", a full day at UW-Superior. This event is incorporated into our Academic & Career Planning (ACP) program.

- Last month 10th grade students went to Northwood Technical College Career Day. Students
 were able to attend breakout sessions with college educators in the field and in the
 classroom learning more about opportunities available at Northwood Technical College.
 This event is also incorporated into our ACP annual plan, meaning students will attend this
 event as 10th graders every year.
- 11th & 12th grade students attended The Unconventional Job Fair head at Legendary Waters. There were breakout sessions, amazing speakers and presenters, representation from many Red Cliff departments displaying and sharing information on their positions and work through and with the tribe.
- We are still working on the schedule for next year, students registered for their classes in January and we hope to have the schedule and student schedules for next year ready shortly. We are working hard to make student schedules intentional with a purpose and a goal in mind. A student schedule indicates the direction they are heading when they graduate. We want our students to be able to choose their path following high school and if they want to attend college that they are college ready and filling their schedules with those classes that help them be successful in 2- or 4-year college programs.
- Scholarship season is in full swing, seniors have many opportunities to apply for scholarships. The deadline for most all scholarships is quickly approaching. Senior Awards & Scholarship night is May 22.
- SCN & ECCP applications & registrations have been completed, board approved and now the classes need to be scheduled, created and placed on student schedules for next year. We have a high number of high school students interested in taking college classes. This year we are anticipating approximately 50+ college classes that need to be created in IC, sections made for students, and student scheduling and registrations procedures need to be finalized by the end of this school year.
- We had four students apply and were accepted to the UW-Green Bay Rising Phoenix program this year to begin in fall 2023. Those who applied last year are continuing in the program. Students may apply as sophomores if they meet the criteria and want to work toward an associate degree while in high school.
- Bayfield School has partnered with DPI for the US Department of Education's Career Connected HS grant. We are being mentored by a school district to improve our College & Career Readiness for our students. More information to come.

School-Based Mental Health Professionals Project *Strategic Priority - Student & Staff Health and Wellbeing, Student Success*

- Continued support of Amy Day and Brian Boyd as they pursue their School Counseling licenses. August Gordon is finishing her School Social work license. Amy Schmidt is finishing her School Psychology license. The grant covers the tuition for all of these individuals with the intent that they continue with our district in supporting students.
- Stephanie met with DPI coordinators to complete the quarterly progress monitoring survey on April 15, 2024. Bayfield School District was referenced as **exemplary** in the implementation of pupil services programing, supporting the professional needs of the pupil services staff, use of grant funds to support student needs.
- August Gordon, Youth Advocate, reports:
 - Attended 7 IEPs/504 meetings.
 - Scheduled 16 individual student meetings.
 - 1 check in/check out with a student daily.
 - 7 walk-ins to provide support.
 - Attended PST meetings, 1 re-entry meeting, communicated with numerous families offering advice on how to connect with community services, multiple conversations and collaborations with outside agencies (Bayfield County DHS, etc.), supported staff and

student needs, continued to serve as a safe de-escalation support and an emotional regulation space within the school setting, regularly engaged in crisis prevention and crisis de-escalation for students with significant needs.

- 2024-25 caseloads and the severity of the needs of students are beyond a reasonable capacity particularly at the elementary and middle schools. Starting the year in this state leaves no room for transfers or new referrals. It is recommended that a K-1 case manager is added and an existing case manager shift to a 5-6 grade case load. These two changes will alleviate the overload at both the elementary and the middle school. An additional paraprofessional is needed for a newly identified student at the ECC. • As of 4/19/24, **167** IEP/evaluation meetings have been held since the start of the school year (compared to **125** one year ago.) **Twenty-five initial** special education referrals have been received, with nine completed. The district currently has 139 students with IEPs (*142 - three students transferring as of 4/22/234) and 15 students with 504 plans. If the remaining initial referrals qualify, there will be 151 students with IEPs in our district. 11 students with IEPs are on track to graduate, 7 of the 11 are 5th or 6th year seniors (students can continue through the year they turn 21 to complete graduation requirements/IEP goals.)
